MINUTES OF THE ONLY REGULAR MEETING  
OF THE BOARD OF TRUSTEES OF THE  
NORTH ORANGE COUNTY COMMUNITY COLLEGE DISTRICT

July 24, 2018

The Board of Trustees of the North Orange County Community College District met for its Regular Meeting on Tuesday, July 24, 2018, at 5:30 p.m. in the Anaheim Campus Board Room.

Board President Jacqueline Rodarte called the meeting to order at 5:30 p.m. and led the Pledge of Allegiance to the Flag.

- B. **Mary Lou Vachet** also spoke in support of application for funds to help the formerly incarcerated via education in order to provide the possibility for a better future and successful reintegration.
- C. **Ben Vega** addressed the Board to share his support for lights and seating for Sherbeck Field, and the overall benefits that the field would provide for Fullerton College.

## REPORTS

A. **Legislative Update:** As part of the Chancellor's Report, **Ashley Walker**, Nossaman LLP Policy Advisor, presented a legislative update that included:

2018-19 District Legislative Priorities: Chancellor's Staff and Nossaman worked together to identify the following priorities based on legislative trends that impact the District's budget, programs, students, and faculty:

- Ensure an equitable funding formula is developed that captures the robust mission of the California Community College system
- Support policy to help students have access to basic needs
- Support policy to enhance campus safety
- Support continued funding for guided pathways
- Ensure thoughtful and intentional inclusion of noncredit in all California community college statewide initiatives

Chancellor's Staff will also be considering ways to advocate for a solution to the Faculty Obligation Number (FON) as the District's legislative priorities are updated.

Status of the Session and District Positions: The District took position on nine bills during the legislative session and worked with Nossaman in advocacy efforts related to the 2018-19 State budget proposals, specifically the new student focused State funding formula. Currently, the following four bills (of the original nine) are still active:

- **AB 1935 (Irwin): Support:** makes supervised tutoring for basic skills and for degree-applicable and transfer-level courses eligible for apportionment funding.
- **AB 3101 (Carrillo): Support:** revises the CCCApply online application so only necessary data is collected during the process and allows for easier integration of noncredit students.

- **SB 1406 (Hill): Support:** extends the sunset date of the baccalaureate degree pilot program by three years.
- **SB 1480 (Hill): Concerns:** makes changes to licensure policy for vocational nurses and psychiatric technicians and creates a new fee each time a nursing program applies for certification by the Board of Vocational Nursing and Psychiatric Technicians (BVNPT).

2017-18/2018-19 Legislative Session Advocacy Successes:

- Weighed in significantly on the 2018-19 State budget process leading to keep noncredit apportionment intact.
- Conducted legislative advocacy days in Sacramento to discuss priorities, bill positions, and impact of the State budget proposals.
- Successfully advocated for amendments to AB 1651 (Reyes, 2017) regarding paid administrative leave.
- Successfully advocated for amendments to SB 68 (Lara, 2017) which expanded the AB 540 program.
- Successfully advocated for amendments to AB 3101 (Carrillo, 2018) to streamline the CCCApply online application process for noncredit students which is still being considered by the Legislature.
- Convened a noncredit coalition with several other districts.
- Worked in coalition to repeal Section 58003.3, Title 5 of the California Code of Regulations, which solidified the District's legal ability to claim apportionment for undocumented noncredit students.
- Chaired the Orange County Community Colleges Legislative Task Force.

Noncredit Advocacy: The District has prioritized noncredit advocacy efforts, has had success related to noncredit regulations and legislation, and has worked in a coalition of other large noncredit colleges and the Association of Community and Continuing Education (ACCE).

Upcoming noncredit policy discussions are anticipated to include: inclusion of noncredit CDCP in the new State funding formula, eligibility of student equity and achievement program for noncredit offerings, AEBG funding, noncredit dual enrollment, and censuses based funding for managed enrollment courses.

Subsequent to the presentation trustees inquired about the vocational nursing and psychiatric tech programs offered within the District, FON advocacy, the impact of SB 1480 on nursing programs, and clarification on AB 1651. Trustees noted that support of the Dream Act was listed among the District's federal priorities without having been vetted or approved by the Board, and questioned the process that led to it being included.

## COMMENTS

Board President Rodarte introduced the comments period by reminding the group, that per the new practice, the written CEO reports were provided in advance of the meeting and asked if anyone had any questions for the CEOs.

- A. **Richard Fee** thanked **Chancellor Marshall** and the Board for the generous benefits package that District managers received and noted that it would allow for the recruitment of high quality managers. He also thanked Dr. Marshall for supporting leadership development and said he looks forward to the upcoming year.
- B. **Dana Clahane** reported on his attendance at the CTA Presidents Conference in San Jose, his concerns with the impact that the District's interest in increasing the lifetime medical requirement to 50 years of service would have, and that negotiations with United Faculty will resume in the Fall.
- C. **Rod Lusch** expressed his dissatisfaction with the "no tolerance attitude" regarding the three-minute time limit during the public comments period which he felt makes it difficult to convey meaningful information to the Board and those in attendance.
- D. **Student Trustee Pascual Castillo** reported on the results of a survey he conducted of Fullerton College Summer session classes.
- E. **Trustee Ryan Bent** stated that comments related to negotiations with the District should be delivered at the podium, and hoped to perhaps revisit the time limit.
- F. **Trustee Jacqueline Rodarte** thanked **Valentina Purtell** for inviting the Board to attend NOCE's graduation. She reported that **Assemblywoman Sharon Quirk-Silva** helped secure \$1 million in State funding for the Fullerton College welding program and highlighted the importance of developing relationships.

**MINUTES:** It was moved by Trustee Ryan Bent and seconded by Trustee Jeffrey P. Brown to approve the Minutes of the Regular Meeting of June 26, 2018 as amended with the noted corrections to the discussion of Item 3.a, Fiscal Year 2018-2019 Tentative Budget, on page 164. **Motion carried with Trustees Bent, Blount, Brown, Dunsheath, Lopez, McClanahan, and Rodarte voting yes, including Student Trustee Castillo's advisory vote.**

## **FINANCE & FACILITIES**

**Item 3.a:** By block vote, authorization was granted to ratify purchase order numbers P0122738 - P0125963 through July 5, 2018, totaling \$15,214,202.30, and check numbers C0047759 – C0047985, totaling \$2,446,245.98; check numbers F0225215 – F0225944, totaling \$308,841.36; check numbers Q0006104 – Q0006117, totaling \$161,502.53; check numbers 88478339 – 88479820, totaling \$7,019,758.53; check numbers V0031537 – V0031553, totaling \$26,639.73; check numbers 70088310 – 70089407, totaling \$197,335.21; and disbursements E8747919 – E8750890, totaling \$26,639.73, through June 30, 2018.

**Item 3.b:** By block vote, authorization was granted to enter into agreements with Anthem Blue Cross and AIG Insurance through Student Insurance for student accident and intercollegiate athletic accident insurance for 2018-19 in the amount of \$191,884 for basic coverage and \$14,908 for catastrophic coverage, for Cypress and Fullerton colleges, effective August 1, 2018.

Further authorization was granted for the Vice Chancellor, Finance & Facilities, or the District Director, Purchasing, to bind the insurance policies on behalf of the District.

**Item 3.c:** By block vote, authorization was granted to continue with the legal services provided by Currier & Hudson at the hourly rate of \$205 plus reimbursable expenses. The term of the agreement is July 1, 2018 through June 30, 2020.

Further authorization was granted for the Vice Chancellor, Finance & Facilities or the District Director, Purchasing, to sign the agreement on behalf of the District.

**Item 3.d:** By block vote, authorization was granted to amend the consultant agreement with R2A Architecture to provide architectural and engineering services for the Anaheim Campus Upper Deck Parking Lot and the Foundation Leak Pre-Design Study and increase the contract amount by \$30,000 from \$118,766 to \$148,766. All other terms of the agreement remain the same.

Further authorization was granted for the Vice Chancellor, Finance & Facilities, or the District Director, Purchasing, to execute the agreement on behalf of the District.

**Item 3.e:** By block vote, authorization was granted to amend the architectural services agreement with Westberg & White for the Renovation of the Existing Baseball Field and Supporting Structures at Cypress College in the amount of \$32,000. The amended amount will bring the total contract to \$129,000 plus \$2,000 reimbursable expenses. The term of the agreement shall be extended through June 30, 2019.

Further authorization was granted for the Vice Chancellor, Finance & Facilities or District Director, Purchasing, to execute the amendment agreement on behalf of the District.

**Item 3.f:** By block vote, authorization was granted to approve the North Orange County Community College District's 2020/21-2024/25 Five-Year Construction Plan prepared and submitted in compliance with California Education Code §81800, et. al. and the California Community Colleges Chancellor's Office directives to meet the submittal deadline of August 1, 2018. Previously submitted IPPs and FPPs remain the same.

**Item 3.g:** It was moved by Trustee Ryan Bent and seconded by Trustee Molly McClanahan to approve out-of-country travel related to Board approved faculty sabbaticals for Carol Henke, William Henke, Pete Snyder, Anupama Mande, and Cathee Mang.

Subsequent to clarification on the sabbatical travel between the two related faculty members and the rationale for requesting Board approval, per BP 7400, Travel & Conference Attendance, the **motion carried with Trustees Bent, Blount, Brown, Dunsheath, Lopez, McClanahan, and Rodarte voting yes, including Student Trustee Castillo's advisory vote.**

Further authorization was granted for the Vice Chancellor, Finance & Facilities or District Director, Purchasing, to execute any agreement on behalf of the District, if necessary.

**Item 3.h:** By block vote, authorization was granted to allow the Fullerton College Foundation to host the North Orange County Chamber of Commerce Sunset Mixer on the

college campus on August 15, 2018 and to allow them to serve alcoholic beverages to attendees.

**Item 3.i:** By block vote, authorization was granted to allow the Cypress College Foundation to host the Cypress Chamber of Commerce Community Festival Mixer on the college campus on July 26, 2018 and to allow them to serve alcoholic beverages to attendees.

**Item 3.j:** By block vote, authorization was granted to approve the purchase of Rosetta Stone licenses in the amount of \$104,991.00, plus applicable taxes. The cost of the licensing is for 36 months.

Further authorization was granted for the Vice Chancellor, Finance & Facilities, or the District Director, Purchasing, to execute the agreement on behalf of the District.

**Item 3.k:** By block vote, authorization was granted to increase the purchase order for Innovative Performance Solutions, Inc. (IPS) from \$130,000 to \$138,103.17. The terms of the agreement remain July 1, 2017 to June 30, 2018.

Further authorization was granted for the Vice Chancellor, Finance & Facilities, or the District Director, Purchasing, to amend the agreement on behalf of the District.

## **INSTRUCTIONAL RESOURCES**

**Item 4.a:** The Board reviewed and discussed the NOCCCD and Anaheim Union High School District (AUHSD) College and Career Access Pathways (CCAP) Dual Enrollment Partnership Agreement 2018-19 as a first reading.

During the discussion, individual trustees expressed the following: 1) frustration with the templates being presented as information items, instead of action items, that do not allow for changes and are “rubber stamped”; 2) the appropriate role of the Board in policy setting; 3) the change in previous practice to now include bringing individual, unsigned agreements before the Board twice; 4) concerns with the timelines and the affect on educational partnerships; and 5) process issues.

Board President Rodarte concluded the discussion by calling for any edits to the CCAP Agreement with AUHSD, which included corrections to Section 1.1 to reflect the intended one-year term of the agreement.

**Item 4.b:** The Board reviewed and discussed the Cypress College Career Access Pathways (CCAP) Dual Enrollment Partnership Agreement 2018-21 with the Los Alamitos Unified School District (LAUSD) as a first reading.

In the subsequent discussion, the following was voiced: 1) corrections were requested to Section 1.1 of the CCAP Agreement with LAUSD to reflect annual renewals; 2) inquiries regarding the advantages to a three-year term and who initiated the request; 3) any amendments will be brought to the Board for approval; 4) a request for feedback or progress reports prior to the cancellation date (possibly at the November 21 study session); and 5) the need to review the documents for printing issues (as noted on Section 17.2).

Trustee Lopez also objected to the process which he deemed problematic, the disregard of assurances made to trustees at the April 24 Board meeting regarding the use of three-year agreements, and reiterated his desire to see the agreements presented as action items up front.

Board President Rodarte ended the discussion by stating her support for the agreements in order to be good partners with local school districts.

**Item 4.c:** The Board reviewed and discussed the Fullerton College Career Access Pathways (CCAP) Dual Enrollment Partnership Agreement 2018-21 with the Brea Olinda Unified School District (BOUSD) as a first reading.

Board President Rodarte inquired whether the BOUSD expressed any concerns over a three-year agreement and was told they did not. No edits to the CCAP Agreement with the BOUSD were requested.

**Item 4.d:** The Board reviewed and discussed the Fullerton College Career Access Pathways (CCAP) Dual Enrollment Partnership Agreement 2018-21 with the Fullerton Joint Union High School District (FJUHSD) as a first reading.

Board President Rodarte inquired whether the FJUHSD expressed any concerns over a three-year agreement and was told they did not. Edits to Section 21.1 of the CCAP Agreement with the FJUHSD were requested to reflect the correct information.

**Item 4.e:** The Board reviewed and discussed the Fullerton College Career Access Pathways (CCAP) Dual Enrollment Partnership Agreement 2018-21 with the Placentia-Yorba Linda Unified School District (PYLUSD).

Board President Rodarte inquired whether the PYLUSD expressed any concerns over a three-year agreement and was told they did not. Edits to Section 21.1 of the CCAP Agreement with the PYLUSD were requested to reflect the correct information.

**Item 4.f:** The Board received as information the Fullerton School District (FSD) and NOCCCD/Fullerton College Educational Consulting Agreement. The Board requested no edits to the contract education agreement between the NOCCCD and the FSD.

**Item 4.g:** It was moved by Trustee Jeffrey P. Brown and seconded by Trustee Barbara Dunsheath to approve the summary of curriculum changes for Fullerton College, to be effective Fall 2018. The curricula have been signed by the Campus Curriculum Chairperson and the College President, and have been approved by the District Curriculum Coordinating Committee.

During the discussion, Chancellor Marshall recommended pulling the Independent/Freelance Paralegal Specialty Certificate and Personal Injury/Civil Litigation Specialization Certificate from the curriculum summary (noted on pages 4.g.27 and 4.g.28). **The amended motion carried with Trustees Bent, Blount, Brown, Dunsheath, Lopez, McClanahan, and Rodarte voting yes, including Student Trustee Castillo's advisory vote.**

**Item 5.c:** By the block vote, authorization was granted for the assignment of professional expert personnel per the professional expert listing.

#### **GENERAL**

**Item 6.a:** The Board reviewed and discussed the proposed schedule for 2018-19 Board meeting presentations and activities. Chancellor Marshall stated that the intent of the proposed format of a monthly business meeting first, followed by a second discussion/study session meeting later in the month, is to allow for effective meetings with meaningful dialogue and provide educational opportunities. She assured everyone that adjustments would be made to the proposed schedule, and that it would be a flexible and iterative process.

Questions regarding the study session meetings included: 1) the duration of the meetings; 2) whether the meetings would be open to the public with voting taking place; 3) the format of the meetings; and 4) whether the focus of the study sessions would be solely on the Board. With regard to potential study session topics, trustees suggested an accreditation update, policy development/formulation, and the Facilities Bond Program.

**Item 6.b:** The Board reviewed and discussed the proposed Board of Trustees Professional Development Program which was developed as a result of the Colleges' accreditation findings and discussed at the recent Board retreat. The proposed program is based on the Community College League of California (CCLC) model and designed to address seven competencies by providing trustees with opportunities to fulfill each area. Trustees recommended listing all of the CCLC conferences and the AALRR Civil Rights in the 21<sup>st</sup> Century Conference to the document, reading of the entire CCLC Trustee Handbook, and having a District sponsored Brown Act training.

In response to clarification on the intention of the accreditation recommendations, Chancellor Marshall noted the following three points: 1) a review of BP/AP 2740, Board Education to ensure alignment and consistency; 2) to codify practices for the Board as a whole, rather than individually; and 3) to develop a new trustee orientation process.

**Item 6.c:** It was moved by Trustee Molly McClanahan and seconded by Trustee Ryan Bent to adopt Resolution No. 18/19-01, Trustee Absence, verifying that Trustee Stephen T. Blount was absent on June 26, 2018 due to illness and, therefore, eligible to receive compensation for the Regular Board meeting held on that date. **Motion carried with Trustees Bent, Brown, Dunsheath, Lopez, McClanahan, and Rodarte voting yes, including Student Trustee Castillo's advisory vote, and Trustee Blount abstaining.**

A signed affidavit from Mr. Blount verifying his absence due to illness will be on file in the Chancellor's Office.

**Item 6.d:** The Board discussed the need for any potential future Board agenda items. During the discussion, it was noted that the concept of this agenda item was also discussed at the recent Board retreat and that trustees should be mindful of the number of items requested due to the impact on staff time.

Trustee Ryan Bent requested a future agenda item to discuss public comments related to negotiations that occur at the podium vs. the dais, and how one adheres to the three-minute time limit, while the other does not.
