MINUTES OF THE REGULAR MEETING OF THE BOARD OF TRUSTEES OF THE NORTH ORANGE COUNTY COMMUNITY COLLEGE DISTRICT

September 8, 2015

The Board of Trustees of the North Orange County Community College District met for its meeting on Tuesday, September 8, 2015, at 5:30 p.m. in the Anaheim Campus Board Room.

Board President M. Tony Ontiveros called the meeting to order at 5:30 p.m. and led the Pledge of Allegiance to the Flag.

REPORTS

- A. **Interim Chancellor Fred Williams** reported on the College Promise Campaign, a national, nonpartisan higher education initiative to build widespread support and broad public understanding for free community college education. He also reported on his meeting with the Anaheim Union High School District Superintendent to discuss student success pathways, and congratulated District finance staff for being the first district in Orange County to close its books.
- B. As part of the Chancellor's Report, the Board honored **Paul McKinley** upon his retirement after 15 years as the Director of Disabled Student Programs and Services, and the Veterans Resource Center at Fullerton College.

COMMENTS

- A. **Greg Schulz**, Fullerton College Interim President; **Bob Simpson**, Cypress College President; and **Valentina Purtell**, School of Continuing Education Interim Provost, reported on activities from their respective campuses.
- B. **Richard Fee** expressed his appreciation to Interim Chancellor Williams for attending a breakfast meeting with the DMA executive board, and commended Human Resources for their work in processing adjunct changes in classification.
- C. **Adam Gottdank** provided a WASC accreditation update, gave kudos to Cathryn Neiswender and Julie Schoepf for their work, and noted that SCE will introduce four new faculty members at its Opening Day event.
- D. **Jolena Grande** reported that the Cypress College Academic Senate held its first meeting, and that the September edition of the *Senate Rostrum* includes an article titled, "Defining the CCC Baccalaureate Degree."
- E. **Pete Snyder** stated that the Fullerton College Faculty Senate also held its first meeting where they appointed a representative to the Chancellor hiring committee, and voiced support for a May 28 on-campus college commencement and the Associated Students Quadchella event.

- F. **Tina Johannsen** reported on the United Faculty executive board meeting and distribution of their first monthly newsletter of the semester.
- G. **Rod Lusch** reported on the first fringe benefit dollars negotiations meeting between the District, CSEA, and United Faculty.
- H. **Natasha Bauman** noted that she had received numerous volunteers to participate on the part-time faculty staff development exploratory committee.
- I. **Student Trustee Tanya Washington** reported on the successful Cypress College Welcome Back event that served over 400 students.
- J. **Student Trustee Francisco Aviles Pino** invited everyone to attend the inaugural Fullerton College "Quadchella" festival on September 17.
- K. **Trustee Jacqueline Rodarte** thanked Vice Chancellor Li-Bugg on the innovation trends summary she provided, commended District staff for their work on the 2015-16 Proposed Budget and Financial Report, and reported on her attendance at the Retirement Board Meeting on August 31.
- L. **Trustee Barbara Dunsheath** referenced two state Chancellor's Office reports on career readiness and accreditation, and an NPR segment on veterans which noted that a majority of veterans attend community colleges or for-profit institutions.
- M. **Trustee Molly McClanahan** encouraged everyone to visit the Fullerton College "Selections from the Fullerton Art Collection" and the Fullerton Museum "Forgotten Faces: The Comfort of Women of World War II" exhibits.
- N. **Trustee Leonard Lahtinen** reported on his attendance at the Hal Sherbek celebration of life and sculpture dedication event. He acknowledged Daniel Billings, the Board of Trustees provisional appointee, in the audience and expressed disappointment that a challenge to Mr. Billings' appointment would result in a special election costing the District over \$200,000.
- O. **Trustee Jeffrey P. Brown** referenced a recent *Los Angeles Times* article which profiled universities that used data to discover that unfulfilled foreign language requirements were the primary reason for students not graduating on time. He hoped that transfer students were being made aware of the potential requirement when applicable, so that they could fulfill the requirement while at a community college.
- P. **Trustee M. Tony Ontiveros** requested that President Schulz provide the Board with copies of the Fullerton College fall football schedule.

MIINUTES: It was moved by Trustee Barbara Dunsheath and seconded by Trustee Molly McClanahan to approve the Minutes of the Regular Meeting of August 25, 2015 as amended. Motion carried with Trustees Brown, Dunsheath, Lahtinen, McClanahan, Ontiveros, and Rodarte voting yes, including Student Trustees Aviles Pino and Washington's advisory votes.

PUBLIC HEARING: At 6:36 p.m. Board President M. Tony Ontiveros opened the public hearing on the Proposed 2015-16 District Budget: District Director of Fiscal Affairs Rodrigo Garcia presented the District's 2015-16 Proposed Budget.

The presentation included a review of the Budget Book, the Strategic Directions Budget Matrix, a Fiscal Analysis, and Outstanding Issues. Mr. Garcia provided the following highlights: The on-going unrestricted revenue equaled \$185,503,080, and on-going unrestricted expenditures totaled \$185,763,234. Mr. Garcia also addressed outstanding issues, including the PERS and STRS rate increases, Prop. 30 sunset, retiree benefits annual required contribution (ARC), and pension reform and healthcare matters.

At 7:32 p.m. Trustee Molly McClanahan moved and Trustee Barbara Dunsheath seconded to close the public hearing. **Motion carried with Trustees Brown, Dunsheath, Lahtinen, McClanahan, Ontiveros, and Rodarte voting yes, including Student Trustees Aviles Pino and Washington's advisory votes.**

Item 3.a: Upon conclusion of the public hearing, it was moved by Trustee Jeffrey Brown and seconded by Trustee Molly McClanahan that the Board adopt the 2015-2016 Proposed Budget with a General Fund Budget totaling \$304,168,091 and associated funds as summarized in the Proposed Budget Book. It is further requested that the Board approve the Gann Appropriation Limit, which is \$315,118,004. In addition, it is recommended that the Board adopt a resolution to certify the approval of entering into agreements and any amendments with the California Department of Education and to authorize the Vice Chancellor, Finance & Facilities, or the District Director, Fiscal Affairs, to sign contract documents for fiscal year 2015-2016. Motion carried with Trustees Brown, Dunsheath, Lahtinen, McClanahan, Ontiveros, and Rodarte voting yes, including Student Trustees Aviles Pino and Washington's advisory votes.

FINANCE & FACILITES

Item 4.a: By block vote, the Board ratified purchase order numbers P0102307 - P0104866 through August 21, 2015, totaling \$3,924,152.12, and check numbers C0042152 - C0042198, totaling \$4,129,652.39; check numbers F0192372 - F0192717, totaling \$732,742.10; check numbers Q0004348 - Q0004396, totaling \$13,207.02; check numbers 88442131 - 88443166, totaling \$7,004,366.09; check numbers 70069454 - 70070120, totaling \$83,245.00; and disbursements E8594249 - E8600019, totaling \$6,077,801.87, through August 31, 2015.

Item 4.b: By block vote, authorization was granted to include Geotechnical Solutions, Inc. in the pool of geotechnical firms to provide geotechnical services for District-wide projects. Further authorization was granted for the Vice Chancellor, Finance & Facilities, to execute the agreement on behalf of the District.

Item 4.c: By block vote, the Board of Trustees rejected all bids for Bid #2015-15, Cypress College Soccer Field Leveling Project, and further authorization was granted for the District Director, Purchasing, to rebid the project at a later time.

Item 4.d: By block vote, authorization was granted to amend the agreement with R²A Architecture to provide design development, construction documents, construction administration and DSA certification services for the 2,486 square feet 1st floor warehouse area of the Anaheim Campus and increase the contract amount by \$3,913 from \$46,423 to \$50,336. The other terms of the agreement remain the same.

Further authorization was granted for the Vice Chancellor, Finance & Facilities, or District Director, Purchasing, to execute the amendment to the agreement on behalf of the District.

Item 4.e: District Director of Facilities Planning and Construction Rick Williams conducted a presentation outlining the Bond Program Manager selection process, the current status of contract negotiations, and the anticipated scope of the agreement. In response to trustee inquiries, further clarification was provided on the length of the proposed agreement, the benefit of District staff augmentation, and the experience, references, and safety practices of MAAS Companies Inc. The Bond Program Manager contract will be presented for approval at the September 22, 2015, Board meeting.
