

APPROVED**MINUTES OF THE REGULAR MEETING
OF THE BOARD OF TRUSTEES
NORTH ORANGE COUNTY COMMUNITY COLLEGE DISTRICT**

May 8, 2007

The Board of Trustees of the North Orange County Community College District met for its Regular Meeting on Tuesday, May 8, 2007, at 5:30 p.m. at the Board Room at the Anaheim Campus.

President Jeff Brown called the meeting to order at 5:30 p.m. and led the Pledge of Allegiance to the Flag.

COMMENTS: MEMBERS OF THE AUDIENCE:

- A. **John Noble** from Cypress College addressed the Board regarding CSEA negotiations, specifically, noting the division being created amongst the classified employees. He expressed his concern with proposed revisions to the CSEA contract.

- B. **Fran Wahl** from Cypress College addressed the Board regarding CSEA negotiations. She expressed her frustration with the negotiations process and urged the Board to offer classified employees a fair contract.
- C. **Rod Lusch**, CSEA President, submitted the following statement for the record:

Several classified employees addressed you at the February 13, 2007 Board of Trustees meeting. One of these employees referred to an article in the CSEA Newline and on February 15 I e-mailed a copy of that article to you in the hopes that it would give you a better understanding of our concerns. I blind copied the e-mail to the employee that addressed you that night so he would know that you were definitely in possession of the document. He sent me an impassionate reply that expressed anger and frustration over the District's attempts to erode classified rights through contract negotiations and in part referred to some of Trustees as clowns. Unfortunately when he sent his reply to me he inadvertently sent it to all who had received the original e-mail, including all of you. One would expect that a public official like a Trustee would recognize that the e-mail was not intended for them and the frustration and anger that this person was feeling not only as an employee but also as a voting constituent.

At the April 24 Board of Trustees meeting this employee once again addressed you, this time to acknowledge that one Trustee from his voter area had met with him for what he felt was meaningful discourse. He also expressed concern and frustration that the other Trustee that represents his voter area had not responded to his invitations to meet after three attempts and ended his comments with yet another invitation. A reasonable person would expect the Trustee to see the invitation as an opportunity to cultivate an amicable relationship with this employee and constituent. Instead the Trustee donned a red rubber nose and taunted the employee. I could excuse the Trustee's actions since he received the ill sent e-mail with the offending word. Obviously enough time had passed for more rational judgment to prevail but clearly that is not what happened.

To this Trustee I suggest that an attempt to resolve this situation with the employee that has extended the invitation to meet; and a less adversarial attitude towards the classified employees' desire to retain the contractual representational rights they have enjoyed for over twenty-five years would go far to re-establish his integrity and credibility.

- D. **Rick VanBeynen** from Cypress College extended his gratitude to Dr. Lewis for the luncheon she hosted for classified employees and her acknowledgment of the importance of these employees.

In response to Trustee Leonard Lahtinen's request, Vice Chancellor Jeff Horsley reported on the progress made thus far regarding the classified negotiation's impasse. Mr. Horsley stated

that a tentative agreement has been reached on 1) salary, 2) on Article 2 - Non-Discrimination, 3) on Article 7 - Job Stewards, and 4) on Article 26 - Release Time for CSEA Negotiations. Rod Lusch added that although progress has been made, CSEA is dissatisfied at the concessions it has had to make, which he believes, are inappropriate requests from the District.

Motion carried unanimously, including the Student Trustees' advisory votes.

CHANCELLOR'S REPORT:

- A. Presentation on Student Learning Outcomes (SLO): As a part of the Chancellor's Report, Carol Mattson from Fullerton College, Nancy Deutsch from Cypress College, and Martha Gutierrez from the School of Continuing Education conducted a presentation in which they identified and defined a Student Learning Outcome, described the ongoing SLO process at each campus, outlined the implementation of the SLO process, and plans for the future.

A discussion ensued with each presenter responding to trustees' inquiries regarding faculty commitment to the SLO process, the definition of SLOs, the need for administrative support, coordinated efforts, and financial support.

- B. Discussion of Board Priorities for the 2007-08 Budget: Trustees began a discussion of priorities for the District's 2007-08 budget. Some of the topics they focused on included: District-wide collaboration, student retention and success, basic skills programming, distance education, marketing, leadership training, retiree unfunded liability, and being an environmentally friendly organization.

COMMENTS:

- A. **Steve Gold** reported that this is his last Board meeting as the Cypress College Academic Senate President and that Cherie Dickey will now assume the duties.
- B. **Rod Lusch** announced that the Classified School Employee Week lunch invitations will be forthcoming.
- C. **Student Trustee Crystal Sandoval** reported on Fullerton College campus activities and Associated Students election results. She announced that David Adame has been elected the Student Trustee from Fullerton College.

- D. **Student Trustee Elsa Garcia** reported on Cypress College campus activities and Associated Students election results, as well as on her statewide involvement with the State Student Association. She announced that Sabrina Tinsay has been elected the Student Trustee from Cypress College.
- E. **Trustee Donna Miller** reported on summary comments from Strategic Conversation #8 and requested a meeting of the Strategic Conversation Subcommittee be scheduled for the month of June.
- F. **Trustee Leonard Lahtinen** inquired, and the Board agreed, on the need to adopt a new resolution in support of the Community College Ballot Initiative, which will be presented to voters in the February 2008 California election.

MINUTES: It was moved by Trustee Leonard Lahtinen and seconded by Trustee Manny Ontiveros that the Minutes of the Regular Meeting of April 24, 2007, be approved as submitted. **Motion carried unanimously, including the Student Trustees advisory votes.**

Item 6.a: In considering the Student Trustees' monthly compensation, it was moved by Trustee Leonard Lahtinen and seconded by Trustee Donna Miller to change section 4.0 of Board Policy 2015, Student Members, to read "...50 percent of the compensation..." instead of the current 25 percent.

During discussion, an amendment to the motion was offered to read "...33 percent of the compensation..." **The amended motion failed with Trustees Brown, Dunsheath, and McClanahan voting yes; Trustees Lahtinen, Matsuda, Miller, and Ontiveros voting no; and the Student Trustees' advisory votes of no.**

The original motion to increase the monthly compensation to 50 percent passed with five yes votes, including the Student Trustees' advisory votes.

It was then moved by Trustee Molly McClanahan and seconded by Trustee Michael Matsuda that the Board adopt amended Board Policy 2015, Student Members. **Motion carried unanimously, including the Student Trustees' advisory votes.**

Item 6.b: The Board received as an information item the 2007 Board Assessment Summaries and the Percentage Comparison of Responses to the 2005 and 2007 Board Assessments. During discussion of the results, the following suggestions were offered: 1) reword question #18 to be more specific about reflecting the community the Board serves; 2) regarding question #19, look at how other community colleges involve the community; 3) encourage new constituent representatives to participate in discussions; 4) establish a Board procedure regarding resource table participation in discussions; 5) hold joint board meetings with other

school districts; 6) establish a community advisory committee with representatives from all feeder schools; and 7) sponsor a Strategic Conversation with community members.

Item 6.c: It was moved by Trustee Manny Ontiveros and seconded by Trustee Michael Matsuda that the Board appoint Sarah Martin as the Fullerton College Student Representative to serve for a term of two years, beginning June 2007, and for a maximum of two consecutive terms, without compensation, on the Citizens' Oversight Committee for the North Orange County Community College District bond projects. **Motion carried unanimously, including the Student Trustees' advisory votes.**
