MINUTES OF THE REGULAR MEETING OF THE BOARD OF TRUSTEES OF THE NORTH ORANGE COUNTY COMMUNITY COLLEGE DISTRICT

March 8, 2016

The Board of Trustees of the North Orange County Community College District met for its Regular Meeting on Tuesday, March 8, 2016, at 5:30 p.m. in the Anaheim Campus Board Room.

Board Vice President Molly McClanahan called the meeting to order at 5:30 p.m. and led the Pledge of Allegiance to the Flag.

BLOUNT: Board Vice President Molly McClanahan reported that a Certificate of Election had been received from the Orange County Registrar of Voters certifying that Stephen T. Blount had been elected to the office of Governing Board Member for Trustee Area 3. She introduced Mr. John Hanna, Rancho Santiago Community College District Board Member, who then administered the Oath of Office to Mr. Blount.

After being sworn in **Trustee Stephen T. Blount** introduced his wife, Bonita Blount, son Jason Blount, and daughter Dr. Talisa Blount.

A. **Keith Vescial**, Cypress College English Instructor, shared his concerns related to the cost of the District's medical premiums and the dire need to improve the overall benefits package.

B. **Jane Walker,** Cypress College Nursing Instructor, addressed the Board regarding the District's failure to move toward the 75th percentile in comparability.

REPORTS

A. As part of the Chancellor's Report, **Dani Wilson**, Fullerton College Dean of the Library/Learning Resources and Instructional Support Programs and Services, presented an overview of the College's Student Diversity Success Initiative (SDSI), including its impact and participation rates. The Initiative, which provides academic and personal support to students, aims to increase the success rates among African-American and Latino males, and other at-risk students. The presentation concluded with a promotional video which included staff and student testimonials.

In the ensuing question and answer session, Dr. Wilson fielded questions related to program participation, promotional uses of the video, life skills coaching topics, increase in student enrollment, and data tracking.

B. **Acting Chancellor Irma Ramos** reported that Interim Chancellor was absent due to his participation in the Los Angeles Community College District accreditation site visit. She noted that the finalists for the Fullerton College Presidency include Dr. Juan Avalos, Dr. Peter Maphumulo, and Dr. Greg Schulz. The College will host a campus forum on Thursday, March 17, 2016, between 9:00 a.m. and noon, to allow the campus community an opportunity to meet the finalists. She concluded her report by sharing that the District was recently awarded the *Risk Management Pays* Award from the Alliance of Schools for Cooperative Insurance Programs. The award includes a \$10,000 check, and highlights the District's effort and commitment to maintaining safe learning environments.

C. Valentina Purtell, School of Continuing Education Interim Provost; Bob Simpson, Cypress College President; and Greg Schulz, Fullerton College Interim President, reported on their respective campus activities.

COMMENTS

- A. **Richard Fee** welcomed Trustee Stephen T. Blount to the Board of Trustees.
- B. **Adam Gottdank** thanked the College Academic Senates for keeping the salary and benefits disparity on the forefront, and praised the efforts of Peter Heimes and his work with students in the High School Diploma Program.
- C. **Jolena Grande** reported on faculty attendance at the Open Education Resource Grant Initiative workshop, and a campus visit by Lark Park, a Senior Policy Advisor for Governor Brown, who toured the Mortuary Science facilities to learn more about the Cypress College baccalaureate degree pilot program.
- D. **Pete Snyder** also welcomed Trustee Blount, and shared that with the "drop down box" information Fullerton College faculty will be able to contact students to encourage them to remain in class.
- E. **Tina Johannsen** read results from a United Faculty survey where respondents said: 1) existing benefits are not up to par; 2) they do not support the District's productivity model; and 3) feel there is a lack movement toward the 75th percentile.
- F. **Rod Lusch** shared that negotiations between CSEA and the District will begin on March 24, 2016, and welcomed Trustee Blount.
- G. **Kent Stevenson** noted that Adjunct Faculty United recently had lunch with Trustee Blount, and also expressed his gratitude to Interim Chancellor Fred Williams for meeting with the Executive Board to provide a budget overview in order to help them better understand the District's budget.
- H. **Student Trustee Tanya Washington** reported on her attendance at multiple campus events, and commended Student Trustee Aviles Pino, whose participation in the recent Anaheim peace rally was featured in the Los Angeles Times.

- I. **Student Trustee Francisco Aviles Pino** shared that Trustee Rodarte was also in attendance at the Anaheim peace rally, and invited everyone to attend an AB540 conference aimed at providing support services for undocumented students on March 11, 2016 at Fullerton College where he will participate as a panelist.
- J. **Trustee Stephen T. Blount** stated his excitement about being a part of the District, and mentioned two books *The Urgency of Now* and *Redesigning America*'s *Community Colleges* that he received from Interim Chancellor Williams.
- K. **Trustee M. Tony Ontiveros** urged participation at the State level to equalize the Full-time Faculty Obligation Number (FON) which unfairly places the District at a significant disadvantage when compared to similar sized districts.
- L. **Trustee Molly McClanahan** noted that the District's number one legislative priority is to equalize the FON. She also applauded the effort put into the Americana Awards' program and the Cypress College Black History Month speaker series.
- M. **Trustee Leonard Lahtinen** asked for clarification on the District's Federal and State Legislative Priorities and the Measure J Bond Program projects projections. He also commended SCE for the role they played in hosting a citizenship fair at the Anaheim Campus that helped over 300 people with the process.
- N. **Trustee Barbara Dunsheath** reported that Strategic Conversation #17 will take place on April 26, 2016, at Fullerton College, and the topic for discussion will be "College Readiness."
